We have had the privilege of acquiring exceptional casks that were previously used to mature sherry or red wine barrique.

## **Verifying Your Details**

Once we have agreed on a rum/whisky cask investment proposal, we will require you to provide AML (Anti-Money Laundering) documents to verify your details. This step ensures compliance with regulatory requirements and helps safeguard the integrity of our transactions.

## **Invoice and Payment**

Upon successful verification, we will send you an invoice for the agreed-upon investment amount. Payment is typically made via bank transfer to ensure a secure and transparent transaction process.



## **Certificate of Ownership**

After payment is received, you will receive a certificate of ownership for your rum/ whisky cask. This certificate includes important details such as the cask number, cask location and this confirms your ownership rights.

Upon request, we can provide you with an Acknowledgement of Ownership of the cask from the warehouse. This document further solidifies your ownership and acts as additional proof of your investment.

## **Exceptional Insurance and Storage**

When you purchase a rum/whisky cask from PDL, we provide 10 years of insurance and storage as part of our pricing. Your cask will be securely stored in a HMRC bonded warehouse, offering optimal conditions for maturation and peace of mind.

## **Full Naming Rights**

Unlike most firms in the UK offering similar services, all rum/whisky casks sold by (PDL) come with full naming rights for the rum/whisky when it is eventually bottled. This is why we will purchase the cask back from you in the future unless you decide to sell at auction or work with you to bottle your Rum/Whisky.

The value of your whisky cask is directly related to the spirit's name of the rum/ whisky inside that cask and also the age.
